TA2TA now offers Zoom Meetings (Zoom) as an alternative platform for training and technical assistance. This platform is excellent for conversation-type meetings and presentations. In Zoom, all attendees have the options to use a web camera, computer microphone, and/or call-in using their phones making engagement and participation easy. For presenting materials, you are able to share your screen and choose the application you would like to share (PowerPoint, Microsoft Word, Excel, Web Browser). Additionally, you can share your presentation materials as download files for the meeting attendees in the chat box. Polling is also available as single answer or multiple choice questions to increase engagement of your attendees.
