#### Post Products and Resources to the Library!

The TA Resource Library is a centralized location where TA providers, grantees, subgrantees, and also potential grantees and subgrantees, can access valuable information developed by all OVW TA providers. Please submit all products and resources developed through your TA award, once approved by OVW in JustGrants, to the <u>TA2TA library</u>, and post such products and resources on the publicly accessible section of your own website, unless OVW agrees that public posting on TA2TA and the recipient's website is not required. For the purpose of your TA award special condition, products and resources are those that would or could be disseminated publically. Such products and resources include, but are not limited to, bench cards, manuals, reports, tool kits, TA briefs, fact sheets, bench books, books, articles, and journals.

Grant Reports are due to OVW on Jan. 30 and the <u>TA2TA website</u> has the capability to provide the statistics of your library resource downloads at the click of a button. When you log in, click the button named "Reporting Stats" to receive your download information. You are able to select the desired reporting period dates.

The Center for Court Innovation's Domestic Violence Resource for Increasing Safety and Connection (DV RISC) is designed to help jurisdictions enhance their approaches to reducing risk and preventing homicide in IPV cases. The Institute for Intergovernmental Research's National Violence Against Women Law Enforcement Training and Technical Assistance Consortium (LETTAC) provides a single point of entry and streamlined program for OVW grantees (and potential grantees) to request law enforcement-related TTA from Consortium experts to tailor strategies, responses, and resources for your specific priorities, needs, and teams.
