Building Comprehensive Sexual Assault Services Programs

This article provides general information and examples about comprehensive sexual assault services as a tool for program development. It is not an exhaustive list, but a list of resources to be used to begin a discussion or assessment or organizational efforts to address sexual violence.

Building Cultures of Care: A Guide for Sexual Assault Services Programs

This guide provides information to support sexual assault services programs in strengthening their organizational and individual responses to survivors of sexual violence through the use of a trauma-informed approach. It provides an overview of the core principles of trauma-informed care and guiding points and questions to help organizations build cultures grounded in the philosophy of trauma-informed service delivery.

Community Assessment Toolkit

This toolkit focuses on key tools and skills for conducting community assessments in order to strengthen services for sexual assault survivors. It is written specifically for multi-service programs, but will be useful for most victim service programs.

It reports on 2005–2006 membership structures, funding sources, staffing patterns, salary and benefit offerings, and board governance options used by responding sexual assault coalitions.

Sexual Assault Coalition Organizational Survey #1 2012: Membership, Infrastructure & Budget

The Resource Sharing Project (RSP) launched a survey in 2011 to collect detailed organizational information from sexual assault coalitions in the United States and territories about various aspects of coalition work. This 2011-2012 organizational survey consists of four shorter surveys distributed between June 2011 and February 2013.
