



# Health Care Resource Guide for Service Providers Aiding Immigrant Victims of Domestic Violence, Sexual Assault, Stalking, Human Trafficking and Other Criminal Activity

This resource guide is intended to aid practitioners in efficiently and effectively locating materials on the health care options for immigrant survivors in the National Immigrant Women's Advocacy Project's (NIWAP) web library. This guide is broken down by type of health care or benefit. One of the tools included is a state-by-state comparison while other tools are focused on the benefits available to different types of visa holders. NIWAP offers a wide variety of resources and hopes this research guide provides some guidance in effectively finding the most useful resource.

# **Comprehensive Overview of Health Care Benefits**

This presentation explains the health care benefits available to immigrant survivors and survivors across the spectrum of statuses, from undocumented immigrants to legally permanent residents. It includes what it means for an immigrant to be "qualified" and "lawfully present" for public benefits. Additionally, the presentation includes information on the new federal and state exchanges and step-by-step instructions on how to sign up for the federal exchange.

It contains information about forensic exams, emergency Medicaid, prenatal care, community health centers and states' responsibilities under the Victims of Violence Act (VOCA.) This chapter is intended to provide practitioners with a thorough understanding of each of the options available to immigrant survivors across the spectrum of statuses.

"Medical Assistance Programs for Immigrants and Immigrant Crime Victims: State by State" features a chart breaking down the programs available to different categories of immigrants by individual states. This chart provides in-depth information about the possible benefits. # "Qualified" and "Lawfully present"

"Qualified" and "lawfully present" are two terms created specifically to deal with the healthcare options available to immigrants. The definitions vary widely based on an immigrant's status and where the individual's application is in the immigration process. # **Access to Healthcare Exchanges**

Since the passage of the Affordable Care Act, the federal government and multiple states have created healthcare "exchanges" to facilitate the purchase of private health insurance by those who are subject to the individual mandate. The presentation also includes the steps an immigrant has to take to register for the exchanges, the possible benefits and a list of which states are participating in the federal exchange and which have state-run exchanges.

"Federal, Partnership, and State Exchanges That Provide State and State-Option Funded Medicaid and Medicaid-Like Services" provides a state-by-state listing of the benefits that immigrants have available to them based on the type of exchange. # **Forensic Exams and Costs**

Getting forensic examinations to assist in the prosecution of sexual assault cases is often funded by the state investigating the crime; finding out the specific requirements of reporting and payment to receive an examination can be found in the state-by-state guide found in Empowering Survivors: Legal Rights of Immigrant Victims of Sexual Assault "Ch. 17.2. #### **Emergency Medicaid**

Emergency care is covered under emergency Medicaid in every state; certain states have different degrees of services covered under the definition of emergency care, depending on immigration status. #### **Post-Assault and Victim Compensation**

Most states have compensation programs for crime victims (reimbursement for medical costs as a result of a criminal action) under grants issued by the Federal Victims of Crime Act, with each state having different procedures and restrictions, some of which occasionally prevent full or partial access to compensation for certain victims based on immigration status. ### **Prenatal Care**

Many states provide some form of state funded non-emergency pre-natal care for immigrants. Similar to other benefits listed above, restrictions exist on a state-by-state basis depending on immigration status.
