Faith: The Double-Edged Sword

- Faith community's past, current, and ongoing role in oppression and marginalization
- · Spiritual trauma
 - o Genocide and Native American Boarding Schools
 - Anti-GLBTQ+ teachings and conversion therapy
 - o Purity Culture and sexual coercion
 - o Enslavement and enforcement of Jim Crow
 - Support for IPV and many forms of abuse
- Faith as strength, resilience, connection, and hope for survivors



Why We Are Here ...

uneven comes and goes with the tide no concerted, systematic effort intermittent inconsistent choppy haphazard



"We are very, very rural, very isolated. People are very isolated. The church may be the ONLY outside-the-home connection, so if pastors can do some education it would be immensely helpful."





"The shelter is not ready to support women of faith. They need a culture change to do this."



"BOTH service providers AND faith communities need to do work and get training and make changes to make this happen."

Advocates said the faith community leaders held these views of the shelter agency:

it "provides abortion, is pro-choice and pro-divorce, breaks up families, and all the staff are lesbians."



The Need for Partnerships between Rural Advocates and Spiritual Leaders



Faith is especially relevant in older and marginalized communities

"respondents, especially minorities, often indicated that their 'first stop' would be a member of the clergy if they were to discuss their [abuse] with anyone."

- educate and influence community norms.




Great Opportunity . . .
