



Award Acceptance

Review your Award Letter and Special Conditions, including instructions on accepting the Award in JustGrants.

Budget Approval

- Grantee budgets are pending OVW review and approval.
- Before OVW approves grantee budgets, grantees may use \$10,000 for participation in and travel-related expenses for OVW-sponsored technical assistance, such as New Grantee Orientation.
- Be aware of communication from OVW regarding budget questions to prevent delay of budget approval.



ALL Program New Grantee Orientation

Who Should Attend? (1)

Grantee teams attend NGO together. Required attendees include:

Project Coordinator or Grantee Point of Contact and:

Required MOU Partners

- Law enforcement
- Prosecutors' office
- Organization serving older adults
- Domestic violence/sexual assault victim services
- If applicable, MOU partner focusing on underserved populations.

Who Should Attend? (2)

New Grantee Orientation is for policy-level leaders with the authority to make decisions about their organization's role implementing your grant project and addressing system change in your community.

What if we don't have a Project Coordinator yet?

Your agency **Point of Contact** should attend and commit to sharing information regarding team members and New Grantee Orientation with the Project Coordinator once hired.

Getting your team approved (1)

Step 1: Assemble your Team

Step 2: Email NCALL with a list of attendees by November 13th. Be sure to include name, title, organization for each partner. NCALL reviews each team for required partners.

Step 3: Once notified, project coordinators ask each team member to register for New Grantee Orientation by November 27th.

Getting your team approved (2)

Step 4: OVW will review and approve the team

Step 5: Upon approval, team members can make their travel arrangements
